#### 4.3 External Audit

Members are advised that the Annual Return has been returned by Mazars who have stated: "In our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met".

They also drew attention to the fact that:

"A. The Chair was acting as the Responsible Finance Officer (RFO) at the time the Council approved the Annual return. The Council has since appointed a new clerk and RFO ensuring that there is now an acceptable level of separation of duties.

B. The Accounts and Audit (England) Regulations 2015 require the RFO to certify, and the Council to approve, the accounts. For 2015/16 the RFO signed the accounts after the Council's approval. We understand that this was the result of a temporary absence of an independent RFO and as a new clerk and RFO is now in place this should not be an issue next year."

A notice has been placed on the website and noticeboard to comply with statutory regulations.

# 9.0 Parish Council Business

- <u>Swims at Fishing Pond</u> Cllr Thomas to update following visit made during September.
- <u>Local Transport Solutions</u> Cllr Thomas to update following the September meeting of the Bernwode Community Bus Committee.
- Road side erosion and kerbing Cllr Chettle was going to obtain two more quotes for the kerbing work. The LAT for the area has inspected Duck Lane for any P1 and P2 defects and has advised that there are no defects currently meeting intervention levels.
- <u>LAF funding for health and fitness</u> Ludgershall's request for fitness equipment has been accepted and Bucks CC will be contacting the parish shortly with details of how and when to invoice for the equipment they have requested.
- <u>Parish Council Website</u> a grant of £2000 has been applied for to help with the new website. Although the budge has been accepted, we are still awaiting the payment. It should be noted however that the BMALC officer has been on leave.
- Defibrillator Cllr Cox to update regarding refresher course for using the defibrillator.
- PA System Cllr Thomas to update regarding the purchase and shared use of a PA system amongst the church fete and village hall committees.
- <u>Celebrate Lottery Funding</u> The Big Lottery Fund is offering grants of between £300 and £10,000 for groups to hold one off events or activities which celebrate their local community. Members are asked to discuss whether or not there are any suitable events they might like to apply for. Deadline for applications is 21 October.

- <u>Willow Tree in Duck Lane</u> Members agreed to pay for works to be carried out to a willow tree parish land in Duck Lane in order for the adjacent landowner to finish pollarding their conifers. The agreed cost was £400 and the works are programmed in for early-mid October.
- <u>Play Area</u> Members agreed to hire KJN to jet-wash the play area rubber crumb and treat it with moss and algae killer at a cost of £180. The works are programmed for 14 October.
