- Swims at Fishing Pond: Stillwater Management Ltd completed the work in February but some residents were unhappy about the appearance of the new stills. Cllr Thomas reported the new stills complied with health and safety requirements, but it had been suggested that the shiny poles would be better if painted. The fishing club have offered to undertake the painting and the Parish Council AGREED to fund the paint.
- 162.6 <u>Village Hall noticeboard</u> The notice board refurbishment is now complete and reerected. Members expressed thanks to Cllr Themis for his undertaking the repairs.
- 162.7 Replacement Oak tree for Village Green Tree has now been planted and is being watered when necessary. The Parish Council wishes to record its thanks to Cllr Cox and to Jack Fisher for his help.

Cllr Themis proposed that the Members should REFUSE TO RATIFY the decision to 'not object', but instead PROPOSED the Council should withdraw the comments already submitted to Aylesbury Vale District Council and object to the Application. This proposal was seconded by Cllr Chetttle and the motion was carried by vote of 4:1. The Chairman did not vote. The reasons to be stated for the objection is over development of the site.
